- A bio-graphical sketch (60-80 words) of Author(s), describing current designation and affiliation/s, has to be sent. It should also contain the full address for the correspondence.
- Article should be of 05 - 08 pages.
- The font size of the title of the paper should be 16 in bold as well as in capital letters. Authors(s) name(s) should be typed in font size 12 in bold, italic and separated by comma. Author(s) affiliations should be typed in font size 12 with single line spacing and should be centered.
- Left Margin: 1 inch, Right Margin: 1 inch, Top and Bottom: 1 inch.
- The entire paper should be typed in Times New Roman 12 font size letters. Paper should be typed in 1.0 inch spacing on one side of A4 size paper only. The figures need to be in JPEG, BMP or TIFF format only.
- All tables, charts and graphs should be in black and not in colour. Wherever necessary, the source should be indicated at the bottom.
- References should be complete in all respect and arranged according to international convention like APA/ MLA style.
